College Admission Procedure

First Year, DSE and ME Admissions:

Admissions play an important role in the functioning of any educational institute. The process and criteria can be different for every organization, yet it is important to follow a standard procedure to conduct admission activities

The institute is part of the centralized admission process (CAP) of the State Common Entrance Test Cell, Government of Maharashtra (CET-Cell). Every academic year after the results of the 12th and required engineering entrance test, admission notification is published by CET-Cell in leading national and regional language newspapers. The same notification is also published on the CET-Cell website and a link to the notification is made available on the college website for student and parent reference. Institute advertises detailed coursewise information in leading and regional daily newspapers. Every year during the admission process institute forms an admission and inquiry cell which helps students and parents to clear their admission-related queries.

Out of total admissions, 80% of seats are filled by CET-Cell through a centralized admission process and 20% of seats are filled by the institute under institute level quota. The process is entirely online and open to all stakeholders for observation.

Interested and eligible students have to fill the online application form on the CET-Cell admission portal and need to upload their required original documents scan copies. These applications will get forwarded to identified Facilitation Centers (FC's) by CET-Cell. Facilitation Center verifies all the uploaded documents of the students which helps CET-Cell to confirm the student eligibility such as required marks and caste-related documents. After the

document verification round, the provisional merit list will get displayed on the CET-Cell admission portal. Separate time is given for the students to clear their grievances if any. After clearing all kinds of grievances CET-Cell displays the final merit list of the students. Eligible students have to fill online option forms through their assigned logins. All admission rounds and the entire admission process are strict as per inter-se merit.

For institute-level admissions, applications are invited from students by giving advertise in newspapers. Application forms are also available on college website from where student can fill the admission form online. A separate merit list of received applications will get prepared as per CET-Cell guidelines and get displayed on the college notice board. All seats are filled as per guidelines and directives of CET-Cell. Admission to ME and direct second-year students are also controlled and monitored by CET-Cell. Institute follows the norms and directives given by CET-Cell, Government of Maharashtra State related to all kinds of admission processes. Since the process is controlled by the government follows Institute which ensures transparency in the admission process. all the admission processes and eligibility criteria as per the directives given by the State Common Entrance Test Cell, Government of Maharashtra State. The entire process is well documented in the brochure published by CET-Cell. Out of 100% seats, 65% of seats are filled through common entrance tests and 15% seats are filled through the All India Engineering Entrance examination (JEE). 20% of seats are filled by the institute under institute level seats by the students who satisfy the minimum eligibility criteria given by the State Common Entrance Test Cell.

For direct second year admission (DSE), vacancies will get communicated by the colleges to the admission authority. There are 10 % seats reserved for diploma students per branch. Entire seats will get fulfilled on the basis of diplomas last year aggregate percentage.

PG seats are filled based on the score in the national level graduate aptitude test for engineers (GATE).

g. voc. Admissions:

From AY 2022-23, for B.Voc two courses are offered: a) Robotics & Automation (intake 60), b) Cloud Computing (intake 60).

Total intake for B.Voc degree course is 120.

Eligibility criteria for B.Voc is 12th Pass (Science / Commerce/ Arts) OR 10th + 2 Yrs. ITI

For B.Voc all seats are filled at institute level on the basis of merit and state government reservation policy. There is no central admission process.

Institute advertises detailed course-wise information in leading and regional daily newspapers. During the admission process institute forms an admission and inquiry cell which helps students and parents to clear their admissionrelated queries. The process is entirely transparent i.e. open to all stakeholders for observation.
