Procedure to file Anti -ragging undertaking (affidavit) online by students and confirmation of Undertaking/Affidavit by Parents for A. Y. (2022-23)

Dear all students of all classes (FE to ME) and Mentors,

There is important compliance required from each student every year while filling admission form for completing the admission process as per the requirement of UGC. So all students need to file an anti-ragging affidavit as per the procedure mentioned below.

The procedure to file anti-ragging affidavits is online as follows.

1. All students have to fill in information online in the following link **compulsorily** for the anti-ragging affidavit as per the requirement of UGC and submit it as per the procedure. You can use some information provided at the end and the youtube link shared in these pages.

Before submitting the form , save it as pdf and you need to keep it with you for record and you have to send it to mentor through email for verification.

2. After successfully submitting the above information, you will receive an email from UGC with the **registration number** (anti-ragging undertaking reference number) **and 3 pdfs. 3rd file is for confirming affidavit, undertaking. Get print of it (only 3rd pdf of affidavit, undertaking).** Show it to parents and confirm it with sign of you and parents (Deponent).

You have to submit this filled form, print of email received after filing antiragging affidavit alongwith your admission form.

Forward email received after filing antiragging affidavit to Mentor (on email id of your batch's mentor) for verification of registration number and Nodal officer for anti-ragging of Institute (on this email id antiragging@vpkbiet.org) by adding pdf of information filled while filing antiragging affidavit.

You have to provide registration details mandatorily in the excel sheet (details/updates will be provided in separate email so). Departments will add details of students, mentors and students or mentors can add registration details so. Mentors will see that all mentees have filled these details in the excel sheet correctly by verifying them from the email forwarded by the mentee.

All students will be required to mention this *Anti-ragging undertaking reference number* while filling the admission form and maybe during filling other forms like exam form etc. So apply for it neatly and remember it.
