Regarding Fee Concession and Scholarship Application

- 1.) Students belonging to Reserved Categories (i.e. SC, ST, NT, SBC, and OBC), as well as those from the Economically Backward Class (EBC), Socially and Economically Backward Classes (SEBC), Economically Weaker Section (EWS), and all eligible Female students (EBC/EWS/SEBC/OBC), will be granted fee concessions strictly in accordance with the norms prescribed by the Government of Maharashtra and the Fee Regulatory Authority (FRA).
- 2.) Students who fail to fill out and submit the scholarship application form within the prescribed time—for any reason (e.g. low attendance, discontinuation of the course, re-admission in same year or failure to provide required certificates)—will not be eligible for any fee concession. Such students will be required to pay the full tuition and other applicable fees as per institutional norms.
- 3.) All concerned students are advised to ensure timely submission of their scholarship applications to avail the benefits.

Note

A) Examination fees will be charged separately at the time of the Exam Form Filling Process.

B) In case a student is found **not eligible** to confirm admission to the higher class for the Academic Year 2025-26, the fees paid towards **provisional** admission for AY 2025-26 will be **refunded** to the concerned student.
